Still fighting for £100,000 for Stonedean Practice. Aim for - surgery 2-3 days a week at Deanshanger community centre. The Old Stratford money is still unallocated

Planning – Roade (24 houses) outside of village confines and for affordable housing. Planning officer recommended, but committee overturned. Very similar to the proposals at the Meadows, so Councillors minded not to set a precedent.

Kingfisher Country Club – 50 lodges. 3 months not accommodation.
