#### TOWN AND COUNTRY PLANNING ACT 1990 PLANNING APPLICATION REF: WNS/2022/1741/EIA FURTHO PIT WAREHOUSING

As you may be aware, Frampton Town Planning acts as the town planning adviser to the Applicant Frontier Estates, for the proposal which is described in the Council's News Letter as 'Furtho Pit Warehousing'.

I acknowledge that the Parish Council objects to the granting of consent for the proposed development. I have however been asked by the Planning Officer, with the support of Ms Stephanie Gibrat the Assistant Director at West Northants Council, to write directly to the Parish Council seeking the Council's position, as a landowner of the PRoW to the south of the A5. I have identified the route of the PRoW in a purple dash on the attached plan.

WNC as the local planning authority, is keen for this PRoW to be improved so that it may function as combined footpath/cycle route. The Applicant is willing to meet the engineering costs in upgrading this path.

My request is to establish whether in the event planning permission is granted, notwithstanding the objections raised by the Parish Council and others, by either West Northants Council or the Secretary of State, the Parish Council as the landowner would be willing for this path to be upgraded to form a shared footpath/cycle route.


